#### **COPYRIGHT**

It is the policy of the Board of Trustees that all College employees follow all rules, regulations and laws which pertain to copyright.

## What is Covered

Although copyright laws cover a wide variety of creations, virtually all of the problems encountered by community colleges involve one of the following creations:

- (a) Printed Materials
- (b) Computer Software
- (c) Audio-Visual Materials including videotaping television programs

#### **Automatic Copyright**

Works created after January 1, 1978, are copyrighted under the federal statute upon their creation. The two fundamental criteria of copyright protection are originality and fixation in tangible form. There is no requirement of novelty, ingenuity, or esthetic merit.

#### Responsibility

The primary responsibility for ensuring that copyright rules, regulations and laws are adhered to rests with the College employee directly using the material. Secondary responsibility lies with College supervisory personnel. Thus, it is incumbent upon all individuals involved with copyrighted materials, both directly and indirectly, to become aware of copyright rules, regulations and laws and what activities associated with copyright are occurring in their respective areas of responsibility.

#### Copyright Resource Centers

Because copyright rules, regulations and laws are complex and often confusing, the College hereby establishes three Copyright Resource Centers. These centers are existing departments staffed with an individual responsible, upon request, for disbursing written literature on specific copyright areas and for assisting individuals in understanding copyright.

### Copyright Ownership

Ownership of Intellectual Property Rights and Copyright for works created by WWCC employees is defined in the Intellectual Property Policy 3910N.

As a general guideline, the 1976 Copyright Act gives ownership to the creator of published and unpublished works. However, when an employee uses *significant* College resources to develop an intellectual property, then ownership is not automatically solely that of the employee and must be defined.
