**Committee Name: Policies & Procedures Committee** 

Mission (Why is the committee needed?): This committee operates as a committee of the College for the development, review and revision of all codified policies and procedures, with the exception of the 7000 Series policies and procedures.

Responsibilities (What are the expectations for this committee?): To review/approve proposed revisions to codified policies and procedures, to initiate revisions when appropriate, to write new policies and procedures when appropriate, to review employee comments regarding new or revised policies and procedures and to make recommendations related to new or revised policies and procedures to the College President and/or the Board of Trustees.

Chairperson(s) (Who will run this committee, set the agendas, conduct meetings, ensure minutes are kept and approved, and report the activities/actions of the committee?): Kandy Frink

Recorder(s) (Who will keep and distribute official minutes of meetings?): The Executive Assistant to the President/Board of Trustees is permanently assigned as the recorder for the committee.

Audience (What audience will receive the minutes?): Faculty and staff

Creating Membership (How are members appointed/elected?): Faculty, Professional and Senate representatives are elected by the Senate; Paraprofessional Representatives are elected by the Paraprofessional Alliance; the Presidential Appointee is appointed by the College President; the Senate Past Chair and Paraprofessional Alliance Chair are automatic non-voting members.

Term (What is the length of the service term for members?): 2 years, with the exception of the SGA Representatives, the Senate Past Chair and the Paraprofessional Alliance Chair which are 1 year terms.

Meeting Frequency (How often will the committee meet?): Once each week for one hour, additional meetings when necessary.

Measures of Success (How will we know if the committee is effective?): The efficiency of this committee is dependent upon how quickly policy stewards complete tasks assigned to them.

Sponsor (Who is the administrative sponsor of this committee?): Dr. Dale.
